



2012 WINTER BRIDAL MARKET – TERMS OF AGREEMENT

Exhibitor/Vendor agrees to the following:

1. Booth space is based on a first- come – first- serve basis and will be assigned at the discretion of TME.
2. No subletting of space without prior written permission of TME.
3. Each vendor in a 10x10 booth will be supplied one 6' banquet table, 2 chairs and black linen. Each vendor in a 15x15 booth will be supplied two 6' banquet tables, 2 chairs and 2 black linens. If the vendor needs additional table and or chairs they may rent them through The Main Event
4. Booth fees are due in FULL upon signing of contract to insure space assignment.
5. Displays are limited to your immediate booth space unless otherwise approved.
6. Vendors are responsible for the cost of any additional materials they require for booth setup and display purposes.
7. All persons associated with your booth must have permission to make changes at time of setup.
8. The Vendor must request access to an electrical outlet and will be responsible for providing their own extension cord if needed.
9. Vendor set up will begin at 12:00 pm on Friday, January 13, 2012 and MUST be completed by 8:00 pm.
10. Vendor set up on Saturday will begin at 8:00am and must be completed by 11:30am.
11. The event on Saturday will begin promptly at **Noon and ends at 4:00 pm. NO EARLY BREAKDOWNS!!**
12. All exhibitor/vendor booths MUST be manned throughout the event.
13. Vendor agrees to allow TME and its partners to utilize their name, products and/or services in advertising and promotional materials unless exclusion is specifically requested in writing.
14. Grand Prize giveaway will be done around 3:45 and winner must be present.
15. Exhibitor/vendor hereby releases TME , and its agents, partners, affiliates, sponsors from any claim for damage and/or injury to property and/or person in conjunction with their participation in the Bridal Market.
16. Any damage done to the building and/or facilities must be reported and paid for by the responsible party and /or assigned vendor.
17. Trash cans will be placed throughout the convention center. If vendor wants a trash can in their booth they will need to provide their own.
18. All areas must be left in orderly and clean condition. Dispose of your own trash and litter in proper receptacles.
19. Each exhibitor/vendor is required to giveaway at least 1 (one) prize, to be given away on the day of the event.
20. Drawing will be done at your individual booths by a live emcee so be prepared to register brides that stop by your booth. For door prize drawings the bride must be present to win.
21. Brides will be given a card with the list of participating vendors. Be prepared to check the box next to your name when the bride visits your booth.
22. TME will not accept any cancellations, therefore signed agreement is acknowledgment of payment due and no refunds will be furnished.

Neither TME or any of its agents, partners, affiliates, sponsors through the Bridal Market will be liable for the acts or omissions of its members or volunteers nor for any loss, damage, or injury from any cause to the exhibitor, exhibitor's employees or property, or any damages caused to the designated exhibit area located at The Hotel Fredonia Convention Center.

The exhibitor agrees to hold harmless TME and all their affiliates for any liability arising by exhibiting in the The Main Event Bridal Market. Any changes to above agreement MUST be in writing and acknowledged by TME and attached to signed form.
